



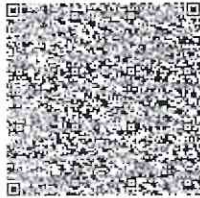




1. NAME:

The name of the trust shall be **G R R Educational and Social Welfare Trust**

2. REGISTERED OFFICE:



The registered office of the trust shall be situated at **118/1, Mayur Vihar, Phase-2, E-Block, Shastri Nagar, Meerut - 250004 (U.P.)** or at such place in the state of Uttar Pradesh or India as may be decided by the Board of Trustees. The working area of the Trust shall be entire India.

3. DEFINITION:

The trust means a **public trust for the benefit of public at large for the advancement of education and any other object of general public utility.**

4. OBJECTIVES:**(A) MAIN OBJECTIVES:**

1. To promote, establish, run, develop and manage Schools, Universities, Institutions, Colleges and all types of organizations in various field beneficial to the community at large, engaged in the activities such as social welfare and advancement of education right from Basic Education, Teachers Education, Medical Education, Medical Hospital, Veterinary Education, Veterinary Hospital, Social Science, Law, Management, Pre-primary, Primary and Secondary Education, Agriculture, Dairy Development, Vedic Science, Cultural, Sports and Other Activities in the interest of social, economic, educational and cultural development in general.
2. To establish Medical Institutions or Colleges, to promote, develop run and undertake medical education in the rural areas in the State of Uttar Pradesh in particular and in the country at large.
3. To establish Research Institutions to promote, run and undertake research in the field of Medical Science and Technological Advancement in the modern medical field.
4. To establish Engineering Institutions or Colleges to promote, and undertake Engineering Education in the State of Uttar Pradesh or at any place in the country.
5. To promote, run and undertake research and development in various fields of education particularly Engineering, Medical Science and Sports.






6. Providing for grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.
7. Granting of financial assistance to any educational institution for granting scholarships, prizes, medals, awards for excellence in studies, sports and scientific research, distribution of books and note books for poor and deserving students.
8. The Trust will not carry out any activities with the intention of earning profit and will perform with service motive only.
9. To provide education for disables and orphan children.
10. To provide primary, secondary and adult education.
11. To run and manage Schools for Secondary & Higher Secondary Education affiliated to any Board.
12. To take all necessary steps to ensure the betterment and improvement of the economic and general conditions of living in the area of operation.
13. To undertake, carry on research, conduct experiments, tests, programmers and make available to the benefit of the community the techniques, new skills and material developed as a result of research carried out by the Trust.
14. To undertake or run various programmes such as Games, Olympiads, Quiz, Meetings, Cultural Programmes, etc. time to time.

(B) OTHER OBJECTIVES:




1. To establish and maintain Libraries, Reading-Rooms and Service and to publish, sponsor and aid publication of Scientific, Engineering and other Educational Literature of quality.
2. To teach and guide about the communicable diseases such as Aids, Covid, Polio etc and consultation in the field of education.
3. To start an international education center for establishing facilities for students coming from different countries.
4. To issue appeals and applications for money and funds, equipments and material in furtherance of the said objects and to accept gifts, donations, matching grants and subscription in cash and securities, loan, deposits and any other property either movable or immovable from any source, including Central and State Governments, Semi-Governmental organizations etc situated in India or outside India.
5. To invest and deal with funds and money of the Trust and to vary, alter or transpose such investments from time to time for the fulfillment of objective of the trust.

6. To purchase or otherwise acquire, obtain or take on lease or hire temporarily or permanently, any movable or immovable property for the purpose of trust.
7. To sell, mortgage, lease, exchanges and otherwise transfer-or dispose off or deal with all or any property, movable or immovable of trust for the fulfillment of objective of the trust.
8. To do other work along, or in Association with Other Person, Trust or Body of Persons, or otherwise, to achieve the aim and objects of the trust.
9. To offer prizes and incentives and to grant scholarships and stipends.
10. To do other activity this will be in the interest of development of science education and educational research in general.
11. To alter, modify and adopt new aims and objects of the trust which shall be passed, by two third majorities of the trustees in a meeting duly convened for the purpose.
12. To construct, maintain, alter, improve or develop any building or workor facilities.
13. To purchase agriculture land or other land or purchase of any other property for the fulfillment of objective of the trust.
14. To print and publish newspapers and magazines and appreciate Journalists, Litterateurs and Writers, open and run a print media.
15. To construct plot & sell them for the benefit of poor.
16. To increase the income of the trust by giving trust's properties on rent, do agriculture activity on agriculture land or by sale of property of the trust for the objective of the trust.
17. Trust can avail the benefit of provision of Income Tax Act, 1961, Wealth Tax 1957 and any other act for taking exemption against income earned by the Trust. For example section 80G and any similar provision of the Income Tax Act, 1961 and comply with all the provisions and conditions against the same.
18. The trust will fulfill its purpose and will spent money in charitable works by receiving grant, donations as per rules of the ministry of Indian Government, Ministry of State Government, MLA, MP, MLC.
19. To take up any other activities as deemed appropriate towards public interests as and when decided by the trustees.
20. The beneficiaries of the trust are a section of the public and not specific individuals.





5. BOARD OF TRUSTEES:

5.1A: COMPOSITION:

The number of trustees of the trust shall be **not less than three and not more than Seven** or may be decided by the board of trustees. The following are the first and life time trustees of the trust.




5.1B: In case of death of President Trustee or Secretary Trustee, the board of trustee will elect or nominate the next President and next Secretary of the trust in place of the founder trustee for future.

5.2 VACATION OF OFFICIALS:

- (1) In case of death of any trustee of the trust, the vacancy shall be filled by majority of the members of board of trustees agreeing to the same or by voting.
- (2) Any trustee of the trust desiring to resign from membership of the trust may so by sending a request/registration letter in writing to the Board of Trustees, who may accept the same and such acceptance shall be subject to the approval by the Board of Trustees of the Trust.
- (3) Any member of the Board of Trustee shall cease to be a member on becoming insolvent.

6. FINANCES:

The profits, income and property of the trust will be applied solely for the promotion of the object of the trust. As set forth above and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus or otherwise, howsoever, to any trustee or any person provided that nothing herein contained shall prevent the payment



in good faith of the trust or other in return for any services rendered to the trust. And no part of the Income or property of the trust shall ever be used or applied for the benefit of any person specified in section 13(1)(c) of the Income Tax Act, 1961.

7. MANAGEMENT:

The management and control of the affairs of the trust shall vest in the Board of Trustees of the trust.

8. POWER AND DUTIES OF THE BOARD OF TRUSTEES:

8.1 The Board of Trustees have power to frame rules, by-laws and regulations as may be considered necessary in the interest and for the betterment, smooth and effective working of the trust.

8.2 The Board of Trustees may alter, modify, rescind or add the rules, regulation and by-laws in the trust deed by two third majorities in the meeting duly convened for this purpose.

8.3 The Board of Trustees shall have full powers and authorities to do acts matters, things and deeds which may be necessary or expedient for the purpose of management of the trust.

In particular the Board of Trustees shall have following powers and authorities:-

(a) To do all things for the purpose of effectively arriving out the objects and activities of the trust.

(b) To constitute sub-committee consisting of the person from outside and or amongst trustees.

(c) To look after and supervise the management of the properties and activities of the trust and to expend money for the purpose.

(d) To fix fees or changes in respect of different activities of the trust and the manner in which the same is to be reserved.

(e) To fix, increase or decrease the rent of the property of the trust.

(f) To keep any person in service or expel or termination the person from service of the trust for misconduct or for any act, which in the opinion of the Board of trustees, is prejudicial to the interest of the trust, provided that no such action should be taken without giving opportunity to the person concerned of being heard.

(g) To invest funds in the banks, or shares, debentures or bonds or elsewhere and to sell or transfer such investment from time to time for the benefit of trust.



- (h) To invest funds to acquire movable and immovable properties either by way of purchase, gifts, donation, mortgage, lease, grant or license.
- (i) To invest funds to construct new building, to repair and renovate existing buildings by making necessary improvement and alteration and to demolish building and to reconstruct the same for the objective of the trust.
- (j) To sell, lease, gift, donate, and create charge or mortgage, any of the movable or immovable properties of the trust.
- (k) To accept or give aid, from or to any institution to propagate the objects of the trust.
- (l) To borrow or raise funds for the trust from bank or any other financial institution or private persons, secured or unsecured through promotes or other obligation or securities of the trust or the mortgage or creating charge on the prosperities of the trust/trustees for the betterment of trust.
- (m) To file, defend and conduct any civil or criminal proceeding and to compromise, withdrew, give up or abandon any claims on behalf of the expenses from the funds of the trust.
- (n) To defend, institute or take any legal proceedings against any employee or any body and during such legal action for the interest of the trust to compromise or abandon any such claims and incur necessary expenditure from the funds of trust.
- (o) To execute on behalf of the trust all contracts conveyance or all sort of documents and to receive and accept the same.
- (p) To pass valid receipts or to delegate powers of passing receipts for money received by the trust.
- (q) To prepare and sanction annual hedges and estimated income and expenditure of the trust.
- (r) To appoint auditor of the trust and fix their remuneration.
- (s) To disapprove, alter, modify, amend or rescind any resolution passed by the board of trustees.
- (t) To appoint members of teaching staff, faculty, legal advisors, engineers, architects, managers, accountants, clerks, agents, nursing staff and other employees which may be required for the management of the trust on such terms and conditions as the Board of Trust may consider proper and may dismiss any such employee. The Board of Trustees may delegate this power to any sub-committee.

9. PROPERTIES OF THE TRUST

9.1. The properties of the trust shall consist of movable and immovable properties include subscription and donation in cash or kind and shall be

9.2. The properties of the trust shall vest in the name of Trust and shall be administered and managed by the board of trustees, subject to and in conformity with the rules, regulation and bye laws of the trust.

9.3. The donations and profits, income and property of the trust will be applied solely for the promotion of the objects of the trust, as set forth above, and no portion thereof shall be paid or transferred directly way dividend, bonus or otherwise how so ever by way of profit to any member or ex-member or any other person claiming through them or any of them, provided that nothing herein contained shall prevent the payment in good faith of remuneration for any services rendered to the trust.

9.4. The trust shall have the power:

- a. To acquire, hold, negotiate, and buy properties, which shall become and remain as Trust Property.
- b. To receive donations, gifts in cash or kind which shall remain and shall be maintained as Trust Property.


10. ACCOUNTS:

12. QUORUM:


For a meeting of a Board of Trustees, there shall be a quorum of at least three fourth (3 or 1/3 of trustees whichever is higher constituting board of trustees) of the total. When a meeting cannot be held for a want of a quorum, the same shall be adjourned for one hour and two members present shall form a quorum for such adjourned meetings.

13. MEETING OF THE TRUST:



16. DISSOLUTION:



4	The trust or institution shall not apply any part of its income from the property held under a trust for private religious purposes, which does not enure for the benefit of the public.
5	The trust or institution established for charitable purpose created or established after the commencement of this act, shall not apply any part of its income for the benefit of any particular religious community or caste.
6	No non-genuine activity shall be carried out by the trust or institution.
7	No such activity shall be carried on by the trust or institution which is not in accordance with all or any of the conditions subjects to which it was registered.
8	The trust or institution shall comply with the requirement of any other law, as referred to in item (B) of sub-clause (i) of clause (b) of sub-section(1) of section 12AB.
9	Where the trust or institution is required to furnish application for registration under sub-clause (ii) of clause (ac) of sub-section (1) of section 12A the said trust or institution shall furnish such application within the time allowed under that clause.
10	Where the trust or institution has adopted or undertaken modifications of the objects which do not conform to the conditions of registration, the trust or institution shall make an application in the prescribed form an manner to the
